## Letter from our Co-Presidents Pat Kirlin and Ellen Jose

The beginning of 2020 has certainly presented new challenges for the Guild. State and archdiocesan mandates regarding COVID 19 have brought our ongoing volunteer activities to support the LSoP and residents of the Home to a screeching halt. For the time being, we are prohibited from entering the Home, and all Guild activities and meetings that take place in the home are suspended. Consequently, the Guild Day of Reflection and the Hats Off to Spring Luncheon were cancelled.

The HOTS Committee has been working behind the scenes to address ways we can partially make up the deficit in our annual contribution to the Little Sisters of the Poor. At this time, we are asking members to consider donating the cost of the luncheon and an additional amount you would spend at the luncheon to the Little Sisters as requested in an eblast you received earlier this month. More information will be forth-coming from the HOTS committee chair, Debbie Simmons.

A special thank you to those who responded to the requests to help the Home by sewing masks and donating items for the its residents. Your generosity is greatly appreciated. The sisters, nursing staff, and other employees of the Home are working around the clock to address the physical and spiritual needs of the residents. While many of you have asked about the status of the residents and have heard news through the grapevine, Mother Francis Gabrial will provide us with official updates when she deems it appropriate.

Prior to the imposed restrictions, two Guild activities brought members together. At the Mass for the Deceased on February 12<sup>th</sup>, we honored Guild members and relatives of Guild members who passed on to eternal life. A sincere thank you to Mary Patout and her committee for making this event memorable for those who attended the mass.

The General Membership Meeting took place on the evening of March 5<sup>h</sup>. We dined on a delicious assortment of soups and salads and witnessed a heartwarming presentation by Jenny Hubbard, Director of the Women's Care Center prior to our business meeting. During the business meeting, we reviewed the proposed bylaws, answered questions, and received suggestions for clarifying language. We trust that everyone has read through the proposed bylaws. A special thank you to those who have responded with suggestions, questions, and positive comments at the meeting and by email. The Executive Committee is reviewing your input. We will make necessary changes and approve the final document before our attorney submits it and other required paperwork to become a 501(c)3 organization. Once approved, you will receive a copy of the new bylaws via email.

During the weeks ahead, let us all be mindful of others as we adopt our individual response to curtail the spread of the Corona Virus, and trust in God's Providence. While social distancing and self-imposed quarantining provides us with opportunity to catch up on sleep and tackle unfinished projects around the home, it also provides us with more opportunities for reflection and prayer. Please pray for the residents, sisters, employees of the Home, our Guild, and our country during these troubled times.

Jenny Hubbard, Director of the *Women's Care Center* was a guest speaker at our general meeting on March 5. She has shared some information and wonderful stories about the current situation at the center.

The *Women's Care Center* is open and continues to serve Indianapolis' most vulnerable. As you know, in these historic times, many families are struggling as they are out of work, and because Women's Care Center is one of the few agencies that remains open, more families than ever are turning to us for emergency supplies-diapers, formula, and wipes.

They continue to see women who are considering abortion. After the Governor declared a stay at home order, Planned Parenthood called our office asking if we could see a woman who was considering abortion, but that their office was not performing procedures that day. We, of course took her in to find out that she was in a domestic violence situation and also needed housing. Since that day, we know that Planned Parenthood has reopened, but are glad to continue to be open next door continuing to help serve Moms and Babies in Indianapolis.

#### 2019 was a record-breaking year!

3,336 women made nearly 8,000 visits to our Indianapolis center; 2,117 precious babies were born to our moms; 3,010 Ultrasounds... that's 60 per week!; March 19th we saw another record breaking 52 clients.

Then Corona hit... We weren't sure what to do. We were asking the same questions as everyone else-Do we stay open? Are we essential? How do we do our part lessen the curve?

- On the first day of the stay-at-home order, a woman came to us early that morning planning to terminate her pregnancy out of fear of the coronavirus-after talking through some of her concerns, she said she was grateful that we were here and that she felt better and she was ok now.
- On the second day, a father showed up at 9:30 in the morning telling us that his daughter had an abortion appointment next door at 10:30, and that they desperately needed someone to talk to. We took them both in and gave the daughter an ultrasound. She skipped her abortion apt.
- That Friday, a social worker called desperate to help her client find a can of formula. They drove 30 miles to our center as we were able to help her as well.

Our new normal:

- Ultrasounds are performed daily. Women enter through the back door to a sealed off area. Julie, our sonographer, is wearing protective gear, disinfecting between every client and staying in this quarantine area as to not expose any of the other staff.
- We are doing phone counseling which has been very effective, but also allows our counselors to work from home. Our counselors are also checking in on previous clients offering material assistance, and a much-needed friend to talk to. With layoffs, and most social service agencies closed and so much uncertainty, more and more families are turning to us for emergency tangible assistance than ever before. In the last few weeks, we have doubled our distribution of diapers!
- We are providing take home pregnancy tests
- We are continuing to help educate moms and dads with online parenting classes in both Spanish and English on our new You Tube Parenting Class channel.

A Woman called whose husband had been depressed after losing his job. Wife thought that this was not a good time to have a baby due to instability. Went over abortion procedures and gave an ultrasound.

All were very excited to see the baby! Father is doing much better and says that the new baby brings hope!
